

2024 APR UPDATE NOTICE /w 2025 HUNT MAP UPDATES

The 2019 Regulation

In 2019, in response to interest among a segment of West Point deer hunters, West Point implemented an Antler Point Restriction (APR), a regulation pertaining to the hunting of antlered deer. The APR implemented here is called a “three-on-one-side” regulation and means that hunters pursuing antlered deer in select portions of the installation where this regulation is in effect (i.e. APR areas) may only harvest an antlered buck if that buck has at least three, one-inch points (incl. brow-tines if present) on at least one antler. For hunters not wishing to participate in this initiative, other portions of the reservation (i.e. non-APR areas) remained exempt from this regulation. This regulation was initially implemented on a five-year trial basis from 2019 through 2023.


The 2024 Update

At the conclusion of the initial five-year trial the West Point Natural Resources Section (NRS) reassessed the regulation in light of evolving program management goals. Factors considered incl. ecological issues (i.e. herd size, health, and its corresponding impact on the landscape, etc.); cultural aspects (i.e. hunter satisfaction in terms of preference and opportunity, etc.); and program features (i.e. regulation simplicity, clarity, enforceability, etc.). As a result, West Point is updating and indefinitely extending the APR with the following updates:

- 1) Adjustment of the APR/non-APR area boundary to Route 293 (all areas east of Route 293 remain APR areas, while all areas west of Route 293 are now non-APR areas)
- 2) Consistent NYS WMUs where APRs apply, junior hunters under 16 years old are now exempt from this regulation and with legal tags, may take any antlered buck. All other state, local regulations apply. **The Updated APR Regulation**

The language of the regulation is now:

“All antlered deer harvested by hunters aged 16 and older from Hunting Areas included in the table below must display no less than three, one-inch points (to include the brow-tines if present) on at least one antler. This regulation shall be in effect for all NYS Big Game Seasons (Early, Regular, and Late), all customer types, and all hunting implements. All other New York State and local procedures and bag and season limits will remain in effect. Failure to comply will result in the suspension of hunting privileges for the remainder of the current hunting season as well as the successive seasons.”



APR Areas now include all hunting areas east of Route 293. These hunting areas include:


The Regulation:

"All antlered deer harvested by hunters aged 16 and older from the following hunting areas must display no less than three one-inch points (to include brow-lines if present) on at least one antler. This regulation shall be in effect for all NYS Big Game Seasons (Early, Regular and Late), all customer types (except for junior hunters) and all hunting implements. All other New York State and local procedures and bag and season limits will remain in effect. Failure to comply will result in the suspension of hunting privileges for the remainder of the current hunting season as well as the successive season."

APR Areas: A3 Bow, CS, CS2 Bow, D1, D2, D3, E1, E2, G1, G2 Bow, H, J1 Bow, J2 Bow, J3 Bow, J4 Bow, J5 Bow, T1, T2, U1, U2, VW Bow, X, Y, Z1, Z2, Z4, Z5, and Z6.

Non APR Areas: A1, A2, B, Buckner Bow, C, F, I, K Bow, L, M, N, O, P, Q, R, R Disabled, RP Bow, and S.

Junior Hunters ages 15 and under are except for the APR and may take any antlered buck with the proper NYS tag in any hunting area on the installation. All other NYS and West Point hunting regulations apply.
